

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Accounting statement

The Council has included Staff costs of £668.25 within total other payments.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's arrangements in the year:

- **Assertion 1** – The Council asserts that it had arrangements in place for effective financial management during the year. The Internal Auditor identified deficiencies in the Council's arrangements.
