Community or County Council? Who is responsible for what?

Rogiet Community Council (RCC) is the most local of the two tiers of government that represent Rogiet, with the other tier being Monmouthshire County Council (MCC). The two councils are responsible for different services as listed below. If you are not sure who you need to speak to on a particular subject, please call us on 07563 543 959 (Monday to Friday 10.00 am to 14.00 pm) or contact us by email or via our Facebook profile and we will be happy to advise you.

The Community Council is committed to providing services and facilities which meet the needs of the people of Rogiet and recognises that it is often appropriate to work in partnership with other organisations, including MCC.

Responsibilities of Rogiet Community Council (RCC)

- Rogiet Hub (The Pavilion) and its services
- Multi Use Games Area (MUGA) and its floodlighting system
- Football pitch, in partnership with Monmouthshire County Council (MCC)
- Grass cutting around the Pavilion, play park, in partnership with MCC
- Flower planters around the village, in partnership with Rogiet Wildlife Friendly Village group for those around the wildflower garden and play park areas.
- War Memorial and flower troughs near the Pavilion, and the 'Unknown Tommy' on Caldicot Road
- Rogiet Playing Fields Car Park, in partnership with MCC
- Play Equipment: the three pieces outside the fenced area, plus the newer items inside the fenced area, all in partnership with MCC (who carry out safety inspections for us)
- Dog waste bins – installing and emptying. We are also members of the County Council initiative "Give Dog Fouling the Red Card".
- Boundary maintenance on council-owned land
- Grants to local community groups
- Consultee on planning applications / changes of use
- Christmas trees and lights
- CCTV for the Pavilion, MUGA, Play Equipment, Car Park / Allotments, and Memorial areas.
- To act as the voice of the residents of Rogiet in front of the higher tiers of government and other agencies.

Responsibilities of Monmouthshire County Council (MCC)

- Education and Social Care
- Community Hubs & Libraries
- Highways Authority: maintenance of public roads and streets, including the fixing of potholes and lighting, clearance of drains, etc. *Note: this doesn't include the M48 and M4 motorways, which are managed by the South Wales Trunk Road Agent (SWTRA) on behalf of the Welsh Government)*
- Planning Authority: processing of householder / business planning applications, changes of use, etc.
- Hedge maintenance / vegetation control on public highways, footpaths and leisure spaces
- Installing and emptying of litter bins on public highways, footpaths and leisure spaces
- Householder and business waste / recycling collections
- Environmental issues: noise, pollution (in partnership with Natural Resources Wales when required)
- Registration of Births, Deaths & Marriages
- Public Transport
- Collection of Council Tax (including the 'precept' element for the Community Council).
