To discuss current state of football dugouts, to consider RCC taking ownership and responsibility of the dugouts, and agree further action

Councillors concerned about the hazardous state of the dugouts – corrugated roof of one dugout on the floor, wood rotting and nails protruding.

Resolved: for the Clerk to write to the football club and ask them to make the dugouts safe within 14 days of instruction. If they are not able to do this the council can organise and invoice them. If this is not done by 14 days after instruction the council will organise removal and invoice the football club. To inform the football club that they can apply to the community council for a grant towards refurbishment of the dugouts.

Resolved: for ClIr R Stallard to install hazard tape around the dugouts as soon as possible.

O23 To receive update from Cllr Dyderski on B4245 issues and agree action

Cllr Dyderski updated council on conversations with a resident who is concerned about parked vehicles at Rogiet Pool causing an obstruction to two-way traffic at the western B4245 entrance to the village. This can cause a backing up of traffic into the higher speed limit zone. It makes it dangerous for cyclists in particular, and visibility is poor for anyone approaching that area, and those living at Rogiet Pool.

Councillors discussed inappropriate speed limits. Cllr Bennett proposed that we make request MCC to investigate the option of reducing the speed limit approaching this part of the B4245, as well as making all other parts of Rogiet 20mph, and to also make Crossway a oneway street. All in agreement.

Resolved: for Clerk to relay these concerns to MCC and ask them for feedback on their decisions/actions to RCC.
